MEMBERSHIP POLICY

The aim of this policy is to clarify how Bexley Voice, (Parent Carer Forum for Bexley, Kent) seeks and manages membership.

Bexley Voice offers membership to:

- Parents/carers living in the London Borough of Bexley, who care for a child or young person (C/YP), aged 0-25, with additional needs and/or disabilities (SEND).
- Professionals who work in the London Borough of Bexley with SEND C/YP age 0-25.

Bexley Voice is pan-disability and supports the parent/carers of C/YP with SEND, age 0-25, with or without a formal diagnosis.

Member's information will be stored under the General Data Protection Regulations (GDPR).

Please refer to the Bexley Voice Privacy policy, to understand how we use and share your membership information. All policies are available to view/download from the Bexley Voice website.

Membership Criteria:

Parent/Carer members must:

- Care for a child or young person (aged 0-25) with additional needs and/or disabilities (with or without a diagnosis). This includes parents, step-parents, foster/adoptive parent, grandparents, siblings and other immediate family.
- Be a resident and/or have a C/YP who attends an educational setting in the London Borough of Bexley.

Professional members must:

Work with, teach, inform, support or advise in a professional capacity, a parent/carer who meets
the criteria for parent/carer membership. This includes (but is not limited to) SENCO's, Teachers,
Support Teaching staff, Educational Physiologists, Therapists, Family Liaison Officers, Advisory
Service, Social Organisations/groups and Inclusion staff.

Parent/Carer Membership offers:

- Opportunities to take part in meetings, focus groups and consultations.
- A regular E-bulletin update on information, events and consultations
- Support and information via email.
- Telephone helpline (limited hours)
- Informative website (also available to non-members)
- An active Facebook Group (private group for parent/carers only)
- Tea and Talk parent/carer support group
- Workshops, seminars and events
- Volunteering opportunities

Professional Membership offers:

- A regular E-bulletin update on information, events and consultations
- Possibilities to engage with our parent/carer members

Membership fees:

To be fully inclusive, both parent/carer and professional membership is free of charge.

Bexley Voice reserves the right to:

- Decline a membership application if the above criteria are not met.
- To withdraw membership for any reason. A written explanation will be provided, on request.
- Reguest members to update their information.

• Update policies at any time, without notice.

Submitting an application for membership

All members must complete a membership form on-line via the Bexley Voice website (paper copies are available if required).

By submitting an application form to become a member of Bexley Voice, all members agree to:

- All information voluntary submitted being stored on by Bexley Voice.
- Bexley Voice sharing your membership information **anonymously** with other relevant local organisations, the National Network of Parent Carer Forums (NNPCF), Contact and their contracted partners, Bexley LA and any other grant providers in accordance with our grant monitoring conditions.
- Allow the use of photographs/videos taken at events/meetings for publicity and promotional purposes.
- Ensure their contact information is kept up to date.
- Bexley Voice adding their details to our mailing list to receive relevant updates and consultations by email. (You are able to unsubscribe from our mailing list by notifying Bexley Voice in writing or by clicking the unsubscribe box at the end of emails received).
- Being contacted by phone for feedback/consultations/membership queries and returning enquiries.
